with:

- - Service Providers: Payment processors, hosting providers, and third-party tools who help us operate the Affiliate Program.
- - Legal Authorities: Where required by law, court order, or regulatory authorities. - Internal Business Transfers: In the event of a merger, acquisition, or restructuring of Olivglobal, affiliate data may be part of the transferred assets.

All service providers are contractually obligated to keep your information secure and confidential.

4. Data Retention

We retain your personal information for as long as your affiliate account is active and as necessary to fulfill tax, accounting, legal, and regulatory obligations. Upon request, we will delete or anonymize your data, subject to any legal or compliance requirements.
